What is the topic you are working on, why is it important, what have you done so far and what are you planning to do and achieve? (*Please specify why it is important for the future roles of universities in Europe*)

The continuous processes of quantification, standardization and metricization constitute a material dimension of the integration of the European university landscape, as governing by numbers could be called a Western modern invention. In the context of the Bologna Process and establishing the European Higher Education Area and European Research Area, at first sight, these tools seem to fit for purpose, as well-known historian of statistics, Theodore M. Porter argued in his *Trust in Numbers: The Pursuit of Objectivity in Science and Public Life.* He argued: "reliance on numbers and quantitative manipulation minimizes the need for intimate knowledge and personal trust" and thus "quantification is well suited for communication that goes beyond the boundaries of locality and community". Universities start to use metrics and indicators, as well as their status on various rankings not only to govern themselves internally, but to build their credibility and trust amongst their various stakeholders – from students and policymakers to local and international communities. The task of this research group is to look beyond these practices and investigate the rationales behind the alternative approaches that are becoming visible in the European Higher Education landscape.

So far we have

- 1. Held a series of Skype meetings and exchanged the draft materials.
- 2. Written 8000 words of a draft that in part can be used as a resource for the development of the full-fledged article but now it is used as a background paper for the working group that helps to understand our research objectives and the shape of the study.
- 3. Designed the empirical part of the study, with preliminary questionnaire and data collection templates.
- 4. Planed the empirical stage of our research.

Overall we plan to:

During 2020

- 1. Conduct the 3 empirical case studies and collect the data.
- 2. Write up the case reports
- 3. Write up the article and submit it to an academic journal by the end of 2020

During 2021

1. Potentially present the results at the CHER conference in Rijeka, Croatia.

At Dec 2021 conference

4. Conduct a panel on the topic of Trust beyond metrics with invited stakeholders

5. We haven't planned that far.

2. Plan of work to be completed during 2020 and to bring to the workshop on 14-16 December 2020
