HOW THE ODIN SECRETARIAT (BASED AT AARHUS UNIVERSITY) PROCESSES YOUR PERSONAL DATA ON WORLDLABS

As a member of the ODIN community on the WorldLabs platform, we are required to inform you about how your personal data will be processed, pursuant to the General Data Protection Regulation.

1. THE DATA CONTROLLER

Aarhus University Nordre Ringgade 1 DK-8000 Aarhus C CVR no.: 31119103

is the data controller responsible for the processing of personal data in the ODIN network.

4. THE PURPOSE OF THE PROJECT AND OF PROCESSING YOUR PERSONAL DATA

The purpose of the ODIN network is to accelerate drug discovery and better diagnostics through the support of open, patent-free and pre-competitive research projects. The ODIN network is thus a project in the interest of society.

To fulfill our mission, the ODIN network will form the basis for intersectoral and interdisciplinary collaborations, which is made possible by the self-imposed sharing of general personal information (name, title, place of work, field of work, and contact information).

The WorldLabs platform is used as a tool for network and ideation as well as for the online application and evaluation process.

We will process your data via the WorldLabs platform to:

- enable all members to profile themselves in the network and allow them to contribute to and crowdsource ideas and partners for need research ideas from the rest of the users of the site.
- support engaging and rewarding interaction between ODIN members.
- enable us to communicate with our members in a professional, coordinated and relevant manner and to target and personalize our email marketing of news, research results and events in ODIN.
- conduct analytics of site traffic and network interactions as anonymized input to the evaluation
 of ODIN progress and impact (data will be assessed by the ODIN Secretariat and the ODIN
 evaluators from Center for Forskningsanalyse, Aarhus Universitet).

5. WHICH PERSONAL DATA WILL BE PROCESSED IN THE PROJECT?

When you request to become a member of the ODIN community on WorldLabs, you can create a personal profile, post and comment on other users' content – all while other users can identify you as the poster, and submit funding applications.

Therefore, the ODIN secretariat will process the following information about you as a participant:

- Name
- Title
- Field of work
- Place of work
- General contact information (if provided by the user)

Please note: It is only allowed to post the above-mentioned personal information on the platform. Please note that the ODIN secretariat will carry out random checks for any personal information posted in our community revealing racial or ethnic origin, political opinions, religious or philosophical beliefs, or trade union membership, and the processing of genetic data, biometric data for the purpose of uniquely identifying a natural person, data concerning health or data concerning a

natural person's sex life or sexual orientation.

6. USE OF AUTOMATED PROCESSING (PROFILING)

Profiling is the automated processing of your personal data. For example processing determined by an algorithm. See below whether processing of your personal data will involve automated processing. Your personal data will not be subject to automated processing.

7. FOR HOW LONG DO WE STORE YOUR OTHER PERSONAL DATA?

Your personal data posted on/submitted to the ODIN community on WorldLabs will be stored as long as you have an active user - or for the duration of the ODIN network (until Q1 2029). See also the general WorldLabs Privacy Policy https://www.worldlabs.org/privacy-policy.

8. WILL PERSONAL DATA BE MADE AVAILABLE OR DISCLOSED TO OTHERS, E.G. RESEARCHERS AT OTHER UNIVERSITIES?

Your personal data collected at the ODIN community on WorldLabs in relation to application rounds will be processed by one or more external data processors (application reviewers). The name of the internal reviewers from ODIN will be listed on the ODIN website www.open-ODIN.dk pursuant to the rules in Article 28 of the General Data Protection Regulation.

The identity of international expert reveiwers (based in the EU/EØS) will not be disclosed. These international reviewers will be individual data controllers and will process data for their own purpose. AU will, if relevant, transfer your personal data to the internal reviewers. AU will solely transfer art 6, 1e information to the reviewers. Personal data transferred from AU to the reviewers shall solely be used for their evaluation of the project proposal and shall be deleted upon the completion of the evaluation. The evaluation is subject to confidentiality.

Information shared on the ODIN community will only be visible to other community members. Each community member is individual data controller processing the personal data for their own independent purposes and subject to their own privacy policy. Personal data accessed by the community members shall be used solely conducting ODIN and shall be deleted upon the completion of the ODIN at the latest.

The ODIN secretariat is responsible for the administration of access to the ODIN community and can – at any time – exclude members from the community, if deemed necessary.

9. HOW YOUR PERSONAL DATA HAS BEEN OBTAINED

The personal data will be obtained from you directly or from the main applicant for a ODIN research project, who submits an application where you are a co-applicant.

10. THE RULES OF THE GENERAL DATA PROTECTION REGULATION AND THE DANISH DATA PROTECTION ACT

We are entitled to process your personal data pursuant to the rules of the General Data Protection Regulation and the Danish Data Protection Act. When doing this, we are obligated to inform you about the rules that apply to our work with your personal data.

Article 6(1)(e) entitles Aarhus University to process non-sensitive personal data about you without your consent, because the project is a task carried out in the public interest and because processing of personal data is necessary for the performance of the project.

11. YOUR RIGHTS UNDER THE GENERAL DATA PROTECTION REGULATION

You have the following rights if Aarhus University processes your personal data as part of a project carried out in the public interest:

- Right to erasure or the "right to be forgotten".
- Right to data portability in some cases, you have the right to receive your personal data and to request that the personal data be transferred from one data controller to another.
- Right not to be subject to an automatic decision based solely on automated processing, including profiling.

Note that your rights may be limited by other legislation or be subject to exemptions, e.g. in relation to research and the exercising of public authority.

12. COMPLAINTS

PROCESS FOR RANDON CHECKS CARRIED OUT ON ODIN'S WORLDLABS PLATFORM

BACKGROUND

The ODIN Secretariat will carry out random checks of information posted on our ODIN community on WorldLabs as well as among the community members' profiles to ensure that any unwanted personal information is not posted.

The ODIN Secretariat will only process information including name, title, field of work, place of work and general contact information (if provided by the user). Thus, the random checks are carried out to ensure that the following information is not present in our community:

- racial or ethnic origin,
- political opinions,
- · religious or philosophical beliefs,
- · trade union membership,
- data concerning health, or
- data concerning a natural person's sex life or sexual orientation.

RANDOM PROFILE CHECKS

Random checks will be carried out **once a month** using the following process:

- 1. The number of members of the ODIN community (NUM) is found by the ODIN administrator on the platform.
- 2. 10 random numbers within the interval 1-NUM (where NUM is the number of community members) is found in Excel using the formula =RANDBETWEEN(1;NUM) or in Danish =SLUMPMELLEM(1;NUM).
- 3. The 10 generated random numbers represent 10 community members, where the number is the member's position in the membership list.
- 4. The ODIN administrator will review the 10 profiles and look specifically for the information stated in the list above. If unwanted information has been posted, the administrator will remove the member from the ODIN community and contact the member directly asking the member to remove the information. If/when the unwanted information is removed, the person can request to join the ODIN community again.

GENERAL REVIEW OF THE ODIN COMMUNITY

The ODIN administrator will continuously monitor the community for posts (or content generated by the community members in general) containing unwanted personal information. **Once a month**, the administrator will go through half of the posts on the platform's 'marketplace' - but no more than a total of 10 posts in a manner similar to the one described for the random profile checks above.

DOCUMENTATION

Following the monthly random checks, the administrator will document the check in a short text file listing the random numbers and the result of each check. The file will be archived in Workzone.
